



# Toppur in Harmony CMO

## Harmony Icelandics, Truro, Iowa

### October 18 & 19, 2025



**CMO is a timed event covering 5 to 15 miles on horseback. Riders attempt to find 5-10 markers using a map and compass. Riders may compete as individuals or teams. A pre-ride practice session available prior to each day's ride. You will need an orienteering compass (example: Silva 7), available at many camping and discount stores. **WHERE:** Harmony Icelandics, 3263 Rustic Trail, Truro, IA 50257 <https://goo.gl/maps/FY5KupJHJBsc5hZ7A>

**DIRECTIONS:** Take I-35 to exit 47 west toward Truro. In Truro, go straight through the stop signs staying on Truro and Peru Roads (G68). You will be on pavement about 3.6 miles. Turn south on gravel R21 at the T intersection with Rustic Avenue. Follow this as it blends onto Pleasant View Trail, winding east then south curving into 320<sup>th</sup> Street. Turn south onto Settlers Avenue, then one more mile, turn west onto Rustic Drive. This will take you to the imposing rock gateposts of Harmony Icelandics. Follow the drive west to the first barn where we will camp for the weekend. We'll have plates at all the corners!

**TRAILS:** Majority are wide mowed, some gravel mixed with grass and dirt. Shoes allowed but not required.

**RIDE FEES:** NACMO Members \$10.00/day for adults, \$5.00/day for juniors (18 & under)  
Non-members \$15.00/day for adults, \$10.00/day for juniors  
First time competitors fee only \$5 first day (insurance only)

**Camping FEES:** \$30 for the weekend. Primitive Camping, portable pens welcome  
\$10 parking & trail use for day riders (non-campers) to help cover Portapotty costs.

**POT-LUCK:** Saturday night pot-luck dinner for all interested. Bring your own plates, utensils, beverage, and a dish to share.

Ride management plans to provide chili and condiments.

#### **Please Note:**

State regulations require horses, mules and donkeys being transported interstate (from one state to another) must have a current Certificate of Veterinary Inspection (health certificate) and negative Coggin's test (EIA). This paperwork must accompany the animal into the State of Iowa.
